Application shall be accompanied by plans showing in detail the location of the proposed work as described in the permit application and shall be prepared by an engineer licensed in the State of Georgia. Plans shall include:

- 1. The size of capacity of the facilities to be installed
- 2. All street names.
- 3. The facilities' relationship to street features such as right-of-way lines, pavement edge, bridges, culverts or other structures.
- 4. Distance from back of curb and/or ditch or edge of pavement.
- 5. Horizontal and vertical to critical elements of the roadway.
- 6. Positioning of all above and below ground devises or equipment.
- 7. Right-of-way width.
- 8. All center lines of ROW and pavement.
- 9. Length, sizes and types of utilities.
- 10. Site location map.
- 11. Cross-section of boring or tunnel.
- 12. Depth of ground cover.
- 13. Erosion Control and Land closure plan if applicable.
- 14. Scale, legend and north indicator.
- 15. Notice of Intent
