City staff members are winding up the process of updating citizen information for the 2025 Berkeley Lake City Directory. Residents who have registered an email address with the city in the past should have already received instructions for updating their directory information online. Updating your listing online is the most efficient method, so please check your spam folder if you can't find it in your inbox. Residents for whom the city does not have an email address on file and who need to update their directory listing may do so by emailing an update form to directory@berkeleylake.com. In case you need an update form, you can download one from the city website and complete it in your browser, Adobe Acrobat or a similar PDF program, then save and email it to directory@berkeleylake.com or print the form and deliver it to city hall. The deadline for updating directory information is February 28th at 5:00 PM so please be sure to respond as quickly as possible! The Directory is a lot of work for our staff, but it is a strong support for neighborliness within our community, and that is so important.

Keck & Wood, the city's contracted engineering firm, is going to be performing annual **inspections of stormwater infrastructure** in the coming weeks. Since we like for you to know who's wandering around your neighborhoods, the stormwater inspector will be wearing a Keck & Wood branded shirt and will be driving a Keck & Wood branded car. This year, the inspections will be in Berkeley Walk and Berkeley Commons, as well as in the Peachtree Lakes commercial subdivision. Every year the city inspects approximately 20% of its stormwater infrastructure in order to identify city infrastructure in need of maintenance or repair. And we're still not charging a stormwater infrastructure fee like other cities.

We were all so saddened by the passing of dear Bob Smith who served our city so well for many years. He is truly irreplaceable, but the City Council was charged by ordinance with picking someone to serve in his place until a special election is held to fill his unexpired term. After careful consideration, they chose **Barbara Geier**, a 30-year resident of Berkeley Walk subdivision and member of BLHA. Barbara was a Chapel board member for 5 years, and their secretary for 4. She has served admirably on the Berkeley Lake Planning and Zoning Commission for the past year. Barbara is a retired lawyer who worked for King & Spalding law firm, Coca-Cola, and Powell



Goldstein law firm. As a Master Gardener she serves our community by working in the Chapel gardens and leads a team that created and maintains a pollinator garden at Berkeley Lake Elementary School. Here she is being sworn in by our City Attorney, Dick Carothers.



Whenever you have **septic servicing**, please make sure the technician completes <u>The Septic System Inspection and Compliance Statement</u> and bring or email the statement and the receipt to City Hall. This will reset the clock in the septic database to five years from the date of most recent service, if the tank is pumped and inspected. The sooner this happens, the better. People can call or email our Marshal Rob Hiller with any questions.
