- a.) **PZV 16-04** 398 Lakeshore Drive. Applicant Greg Harper for Owner Condestra Development, LLC requests relief from:
  - 1. Section 78-89 (g)(2) of the Zoning Ordinance to reduce the required side setback for a proposed dock and boat slip from 12.5 feet to 8 feet; and
  - 2. Section 78-89(g)(3) of the Zoning Ordinance to reduce the required separation of a dock/boathouse from the opposite shore from 75 feet to 25 feet.

FINAL Minutes Planning & Zoning Commission Meeting June 14, 2016 Page 1 of 2 Schaap announced the item. Applicant Greg Harper was present to explain his request. He explained that he is purchasing the property and the request is a contingency of the purchase. The lot is on a very long, narrow cove and is pie-shaped. He proposes to locate a swim deck and covered boat slip as tight to the shoreline a possible and to get some view down the lake. The roof over the deck would be a nearly flat shed roof and would be a green roof.

Kaffezakis stated that while the commission had granted variances in similar situations regarding reductions in the separation in order for people to use their properties with a dock, he was hesitant to accept the reduction in the setback. Schaap questioned leaving enough room to access the end of the cove Harper stated that he planned to use a floating boat slip that could be moved to allow better access if needed.

Kaffezakis moved to approve only the request to reduce the separation between the proposed boat house and the opposite shore to 25 feet. Allen seconded. All voted in favor. Therefore, the motion was approved.
